

Komeer Account Roles



Council

The council will act as the account owners and will manage the overall data. Ensuring that all data is GDPR compliant with the help of the inbuilt tools in Komeer.





Police

The local Garda/PSNI/Police will engage with the account members on issues of crime prevention. They will send alerts to members but have not direct control of the account data.

Community Leaders

The community leaders will act as sub admins with limited access to account data. They will engage with their local members on community awareness and local events. **03** Case Study
